- manage our activities to minimise our impact on air, water, soil, flora, fauna and cultural values
- minimise the generation of waste and use waste recycling facilities where available
- ensure understanding of environmental requirements and implementation of standards among our employees, suppliers and contractors
- create opportunities to engage with affected and interested stakeholders to understand their views and inform decisions made about management of the forest estate
- commit to not deploying genetically modified organisms
- set and review objectives and targets for improvement of forest management outcomes
- monitor, audit, review and publicly report forest management performance
- ensure adequate and trained resources are available to meet objectives of management
- manage emergency situations, to protect life, property, community assets and forest values
