FORESTRY REGULATION 2022 - SECTIONs 6 & 7

CLOSURE OF PART OLNEY STATE FOREST

FORESTRY CORPORATION OF NEW SOUTH WALES HAS RESERVED THE AREA DESCRIBED BELOW AS 'THE CLOSED AREA' FOR THE EXCLUSIVE USE OF ITS CONTRACTORS, SUPPORT AND SUPERVISING STAFF CARRYING OUT HARVESTING OPERATIONS DURING THE PERIOD DESCRIBED BELOW AS 'THE CLOSURE PERIOD'.

THE ENTRY OF ALL PERSONS INTO THE CLOSED AREA DURING THE CLOSURE PERIOD, OTHER THAN PERSONS AUTHORISED IN WRITING BY THE FORESTRY CORPORATION OF NEW SOUTH WALES, IS HEREBY PROHIBITED. PERSONS ENTERING INTO OR REMAINING IN THE CLOSED AREA DURING THE CLOSURE PERIOD WITHOUT FORESTRY CORPORATION OF NEW SOUTH WALES' PERMISSION ARE LIABLE TO PROSECUTION, MAXIMUM PENALTY \$2,200 PER OFFENCE.

DESCRIPTION OF THE CLOSED AREAS

That part of Olney State Forest No. 124 enclosed by the mapped boundary:

- A. commencing on Wollombi Brook, just south of the gate located on Basin Forest Road, in the vicinity of the Basin Camp Ground, then continuing in a clockwise direction around the Closed Area;
- B. then, generally in a westerly direction following Wollombi Brook downstream to the Private Property and State Forest boundary, marked 'Point B' on the map;
- C. then along the Private Property and State Forest boundary to Point 'C' on the map; then,
- D. in a north westerly direction following an unnamed drainage feature to the State Forest and Private property boundary, marked Point 'D' on the map, then,
- E. in a northerly then easterly then northerly direction following the State Forest and Private Property boundary to Point 'E' on the map at the intersection of Lizard Trail, and the Private Property and State Forest boundary; then,
- F. along the Private Property and State Forest boundary to Point 'F' on the map near Glider Point Road;
- G. then, in a generally easterly direction along and including Glider Point Road to the intersection of Glider Point Road and Murrays Forest Road at 'Point G' the map, then,
- H. continuing in a generally easterly direction along and including Murrays Forest Road to the intersection of Murrays Forest Road and Walkers Ridge Forest Road, marked 'Point H' on the map then,
- I. in a generally southerly direction following Walkers Ridge Forest Road to the intersection of Walkers Ridge Forest Road and an eastward extension of the Great North Walk, marked 'Point I' on the map then,
- J. following the eastward extension of the Great North Walk to the west, to where it joins the main Great North Walk, marked 'Point J' on the map then,
- K. following the main Great North Walk in a generally southerly then westerly direction to the intersection with Rock Lilly Walking Track, near the Basin Camp Ground, marked 'Point K' on the map
- L. then, following Rock Lilly Walking Track to its crossing of a tributary of Wollombi Brook, marked 'Point L' on the map; then following the outer edge of the Basin Camp Ground in a generally westerly direction, to link back to point 'A' on the map.

To be clear, the Basin Camp Ground is open and not included in the Closed Area, and persons may walk the Rock Lilly Walking Trail and Great North Walk but are not to leave either and otherwise enter the Closed Area.

DESCRIPTION OF THE CLOSURE PERIOD

Between 7:00 am Friday 16th May 2025 and 7:00 am Monday 1st December 2025.
