FORESTRY REGULATION 2022 - SECTIONS 6 & 7

CLOSURE OF PART STYX RIVER STATE FOREST

FORESTRY CORPORATION OF NEW SOUTH WALES HAS RESERVED THE AREA DESCRIBED BELOW AS 'THE CLOSED AREA' FOR THE EXCLUSIVE USE OF ITS CONTRACTORS, SUPPORT AND SUPERVISING STAFF CARRYING OUT HARVESTING OPERATIONS DURING THE PERIOD DESCRIBED BELOW AS 'THE CLOSURE PERIOD'.

THE ENTRY OF ALL PERSONS INTO THE CLOSED AREA DURING THE CLOSURE PERIOD, OTHER THAN PERSONS AUTHORISED IN WRITING BY THE FORESTRY CORPORATION OF NEW SOUTH WALES, IS HEREBY PROHIBITED.

PERSONS ENTERING INTO OR REMAINING IN THE CLOSED AREA DURING THE CLOSURE PERIOD WITHOUT FORESTRY CORPORATION OF NEW SOUTH WALES' PERMISSION ARE LIABLE TO PROSECUTION, MAXIMUM PENALTY \$2,200 PER OFFENCE.

DESCRIPTION OF THE CLOSED AREAS


That part of Styx River State Forest No. 339 enclosed by the boundary commencing at the intersection of Raspberry Road and Kempsey Road, marked Point 'A' on the map; then, in a clockwise direction around the closure area, generally in a southerly direction along the Kempsey Road to the boundary corner with an unnamed road, marked Point 'B' on the map; then generally in a southerly direction along the State Forest boundary to an un-named drainage line, marked Point 'C' on the map; then meandering in a generally northerly direction along un-named drainage lines to the junction with another un-named drainage line, marked point 'D' on the map; then in a generally westerly direction along this un-named drainage line to Raspberry Road, marked point 'E' on the map; then generally in a northerly direction along Raspberry Road to the intersection with the Kempsey Road, back to point 'A' on the map.

That part of Styx River State Forest No. 339 enclosed by the boundary commencing at the intersection of the Kempsey Road and Honey Gully Road, marked Point 'F' on the map; then, in a clockwise direction around the closure area, generally in a westerly direction along Honey Gully Road to the boundary corner with an unnamed drainage line, marked Point 'G' on the map; then generally in a northerly direction along un-named drainage line to the junction with another un-named drainage line, marked point 'H' on the map; then in a generally easterly direction along this un-named drainage line to the Kempsey Road, marked point 'I' on the map; then generally in a southerly direction along the Kempsey Road to the intersection with Honey Gully Road, back to point 'F' on the map.
