**FORESTRY REGULATION 2022 - SECTION 6 & 7** 

## CLOSURE OF PART GLADSTONE STATE FOREST, AND PART VIEWMONT STATE FOREST

FORESTRY CORPORATION OF NEW SOUTH WALES HAS RESERVED THE AREA DESCRIBED BELOW AS 'THE CLOSED AREA' FOR THE EXCLUSIVE USE OF ITS CONTRACTORS, SUPPORT AND SUPERVISING STAFF CARRYING OUT HARVESTING OPERATIONS DURING THE PERIOD DESCRIBED BELOW AS 'THE CLOSURE PERIOD'.

THE ENTRY OF ALL PERSONS INTO THE CLOSED AREA DURING THE CLOSURE PERIOD, OTHER THAN PERSONS AUTHORISED IN WRITING BY THE FORESTRY CORPORATION OF NEW SOUTH WALES, IS HEREBY PROHIBITED.

PERSONS ENTERING INTO OR REMAINING IN THE CLOSED AREA DURING THE CLOSURE PERIOD WITHOUT FORESTRY CORPORATION OF NEW SOUTH WALES' PERMISSION ARE LIABLE TO PROSECUTION, MAXIMUM PENALTY \$2,200 PER OFFENCE.

#### **DESCRIPTION OF THE CLOSED AREAS**

That part of Gladstone State Forest No. 163 and Viewmont State Forest No. 1035 enclosed by the boundary commencing at the intersection of Spicketts Creek and Williams Road (marked point 'A' on the map), then moving in a clockwise direction around the closure area, generally in a south-easterly direction following Spicketts Creek to the intersection with State forest boundary (marked point 'B' on the map), then following the Gladstone State Forest boundary in a general southerly direction to the intersection with Bellingen/Bowraville Road (marked point 'C' on the map) Note\* Bellingen/Bowraville Road remains open to the public, then following the western edge of Bellingen/Bowraville Road to the intersection with the northern boundary of Viewmont State Forest (marked point 'D' on the map), then following the Viewmont State Forest boundary in a general south-easterly direction to the intersection with Bollanolla Nature Reserve (marked point 'E' on the map), then following the Viewmont State Forest boundary in a general westerly direction to the intersection with Bowraville Nature Reserve (marked point 'F' on the map), then following the State forest/Bowraville Nature Reserve common boundary in a general northerly direction to the intersection of Bellingen/Bowraville Road, Viewmont State Forest and Gladstone State Forest (marked point 'G' on the map), then following the Gladstone State Forest boundary in a general north-westerly direction to the intersection with Williams Road (marked point 'H' on the map), then following Williams Road to the intersection with Spicketts Creek (marked point 'A' on the map).
