FORESTRY REGULATION 2022 - SECTION 6 & 7

CLOSURE OF PART LOWER BUCCA & ORARA EAST STATE FOREST

FORESTRY CORPORATION OF NEW SOUTH WALES HAS RESERVED THE AREA DESCRIBED BELOW AS 'THE CLOSED AREA' FOR THE EXCLUSIVE USE OF ITS CONTRACTORS, SUPPORT AND SUPERVISING STAFF CARRYING OUT HARVESTING OPERATIONS DURING THE PERIOD DESCRIBED BELOW AS 'THE CLOSURE PERIOD'.

THE ENTRY OF ALL PERSONS INTO THE CLOSED AREA DURING THE CLOSURE PERIOD, OTHER THAN PERSONS AUTHORISED IN WRITING BY THE FORESTRY CORPORATION OF NEW SOUTH WALES, IS HEREBY PROHIBITED.

PERSONS ENTERING INTO OR REMAINING IN THE CLOSED AREA DURING THE CLOSURE PERIOD WITHOUT FORESTRY CORPORATION OF NEW SOUTH WALES' PERMISSION ARE LIABLE TO PROSECUTION, MAXIMUM PENALTY \$2,200 PER OFFENCE.


DESCRIPTION OF THE CLOSED AREAS

That part of LOWER BUCCA State Forest No.29 & ORARA EAST State Forest No.536 enclosed by the boundary commencing at the intersection of the State forest boundary and Eastbank Forest Road (marked point 'A' on the map), moving in a clockwise direction around the closure area, generally in a Easterly then a Northerly direction following the State forest boundary to the intersection of the State forest and Private Property boundary (marked point 'B' on the map). Then following the State forest boundary in a generally easterly direction to the intersection of Bucca Road and Cemetery Road (marked as point 'C' on the map). Then following the State forest boundary in a generally southerly direction (excluding an area of State forest to the east of Bucca and Wears Road) to the intersection of McNamara Road and the State forest boundary (marked as point 'D' on the map). Then following McNamara Road in a westerly direction, then Gates Ridge Road, Slip Road and Boffs Road in a generally southerly direction to the intersection of 5/1 Road (marked point 'E' on the map). Then following 5/1 Road and Mt Coramba Road in a generally southerly direction to the top of Mount Coramba, then following Hopes Road in a generally South-westerly then a North-westerly direction to the intersection of Tiger Fire Road and the State forest boundary (marked point 'F' on the map). Then following the State forest boundary in a generally northerly direction to the intersection of Eastbank Forest Road and the State forest boundary (marked point 'A' on the map).
