THE ENTRY OF ALL PERSONS INTO THE CLOSED AREA DURING THE CLOSURE PERIOD, OTHER THAN PERSONS AUTHORISED IN WRITING BY THE FORESTRY CORPORATION OF NEW SOUTH WALES, IS HEREBY PROHIBITED.

PERSONS ENTERING INTO OR REMAINING IN THE CLOSED AREA DURING THE CLOSURE PERIOD WITHOUT FORESTRY CORPORATION OF NEW SOUTH WALES' PERMISSION ARE LIABLE TO PROSECUTION, MAXIMUM PENALTY \$2,200 PER OFFENCE.

DESCRIPTION OF THE CLOSED AREAS

That part of Viewmont State Forest No.1035 enclosed by the boundary commencing at the intersection of Cpt 308/1 and unnamed private road (marked as point 'A' on the map); then moving in a clockwise direction around the closure area, following the northern State forest boundary east to the intersection with Bollanola Nature Reserve and Cpt 305/1 Road (marked as point 'B' on the map); then following the State forest boundary in a north-easterly direction to the intersection with Slees Trail (marked as point 'C' on the map); then following the State forest and National reserve boundary in an south-easterly direction to the intersection with Valla Road (marked as point 'D' on the map) Note* Valla Road remains open to the public, then following the State Forest boundary to the easternmost corner of the Viewmont State Forest (marked as point 'E' on the map), then following the State forest boundary west to the intersection with Valla Road (marked as point 'F' on the map); then following in a south-westerly direction along Valla Road to the intersection with Sheathers Trail (marked as point 'G' on the map); then following along Sheathers Trail to the intersection with Bowra View Trail (marked as point 'H' on the map); then following along Bowra View Trail to the intersection with the southern State Forest boundary (marked as point 'l' on the map); then following along the southern State Forest boundary to the intersection of Cpt 308/1 Road (marked as point 'J' on the map), Note* Cpt 308/1 Road is closed to the public then following along Cpt 308/1 Road to the intersection with the unnamed private road (marked as point 'A' on the map.)
