Purpose

The purpose of this position is to effectively operate a range of plant and medium/heavy vehicles under general direction on a wide range of forestry operations (forest road construction and maintenance, plantation establishment and fire control), ensuring the plant and medium/vehicles are operated in a safe, effective manner in compliance with environmental and safety standards.

Key Areas of Responsibility

Road & Trail Construction and Maintenance, and Site Cultivation	 Undertake a day-to-day program of forest road works including road maintenance, upgrade and construction. Work tasks include manual labour and plant and medium/heavy vehicle operation (including the need for a Heavy Combination - HC license to shift heavy plant with a tri-axle plant trailer). Operate a range of plant (including grader, dozer, loader, roller and excavator) and medium/heavy vehicles (medium rigid/combination tipper trucks and heavy rigid/combination tipper trucks) in a safe and effective manner ensuring compliance with environmental standards. Undertake daily maintenance and optimise utilisation of the plant to gain maximum efficiency and guard against breakdowns. Complete administrative tasks such as a pre-start plant checks, running returns, Logbook Me, timesheets and productivity reports on time and to prescribed standards. Undertake maintenance of signs, pipes drainage etc to ensure compliance with appropriate standards.

Key Challenges

- Effectively balancing the day to day operational demands of the role.
- Timely support and communication to internal and external stakeholders.
- Working alone and/or travelling extensively (mainly driving) and working extended hours.
- Meeting fitness requirements for the job (e.g. ability to walk on uneven terrain for extended periods, working outdoors in a variety of weather conditions).
- Keeping up to date with and applying relevant codes and regulatory requirements. Complying with Safety Management Systems.
- Ability to complete work to a high standard within a given timeline.
- Ability to plan method of work and interaction with other machinery.
- Complying with SPD Forest Management System.
- Solving logistical problems that occur within the scope of the position.
- Working in remote locations under a range of weather conditions.
- Effectively contributing as part of a team to fire management and other Regional activities

Communication

- Liaising with Supervisor and other Roading plant operators for the prioritisation, coordination and completion of road maintenance, construction and other tasks as required.
- Roading Operations Controller / Coordinator and Harvesting & Roading Manager on an as needs basis.
- Ability to communicate effectively with your supervisor, co-workers, contractors and external stakeholders as required.
- Effective use of required technology (e.g. iPad, phone Apps, email and corporate web-based systems).
- Strictly follow FCNSW radio procedures when communicating via radio during operations.

Decision Making Authority & Limit

- Ability to interpret and work in accordance with daily and weekly work plans including maps and forms.
- Recognise and report incidents or non-conformances with plans, procedures or codes.
- Provide input to and comply with mitigating actions for identified non-conformances with operational. plan or work instructions.
- Identifies and solves problems in own work area and identifies problems in other work areas where they affect the activities of the position.
- Hazard identification and incident reporting.

- Ability to lead and manage a small team.
- Experienced in working safely in a high risk environment.



- Basic computer skills and ability to learn and apply new technologies to your work.
- Knowledge and understanding of forestry management and protection, including weed and pest control, fire management, planning and suppression, and silviculture.
- Relevant tertiary qualifications.
- Sound plant and medium/heavy vehicle operation and maintenance skills.
- Experience in road construction and maintenance techniques, including aspects of quality control.
- Knowledge of current legislation relating to road construction and maintenance.
- Knowledge of technical aspects of road maintenance and construction.
- Good organisational, decision making and problem-solving skills with an ability to work unsupervised for limited periods.
- Ability to undertake fire standby, fire suppression, hazard reduction activities using heavy plant.
- Ability to work from and interpret complex instructions and plans, including ability to read maps, navigate, accurately interpret and record figures and basic field data.
- Willingness to work extended hours.
- Capacity to learn and undertake training in new skills.
- A level of fitness adequate for manual work and firefighting.
- Good communication skills.
- Ability to learn how to use an iPad to undertake tasks such as reporting incidents or hazards, roading requests, read and answer e-mails, use Logbook Me, and such software as and when required.
